#### Shelf life

Shelf life is 24 months from date of manufacturing.

HSC 2321 should be stored at normal ambient conditions, in the original

containers kept tightly closed at dry and cool place. Container once opened should be tightly closed to avoid contamination by foreign materials. resin should not be exposed to moisture, sunlight, or other heating media to avoid agglomeration. Under proper storage conditions, it has a storage life of at least two years from the date of manufacturing. It is advised to take proper precaution while emptying bags of HSC 2321 to avoid discharge of static electricity that might be present on the packing material surface. A good exhaust to avoid formation of a cloud of fines at discharge area is recommended.
